BOARD OF ADJUSTMENT

The Board of Adjustment meets on call to hear and decide appeals where it is alleged that an error was made in any order, requirement, decision, or determination made by an administrative official in the enforcement of the zoning ordinance.

AFFORDABLE HOUSING BOARD

The Affordable Housing Board meets on call and serves as a citizen advisory group for affordable housing-related Community Development applications to the State CDBG program. This Board is responsible for the decision-making as to the method used in rehabilitating houses.

LAKES, PARKS AND RECREATION COMMISSION

The Lakes, Parks and Recreation Commission meets the first Tuesday of the month at noon. To recommend to the City Council policies, rules, legislative initiatives, development plans, programs and other actions which serve to preserve and protect Kirksville's lakes, park lands and open space conservation areas; which enhance active and passive recreational activities for the residents of Kirksville; which maintain public safety; and which provide for long-range planning for future uses and community needs regarding lakes, parks, open spaces and recreational facilities and programs in and around Kirksville.
