Commercial Remodel Permit

Zoning Requirements – The Zoning classification should be verified for your project before a remodel if the planned use will be different than current or previous use. Kirksville's zoning districts have minimum lot size, building height, setback, parking, landscaping, and other requirements. A handbook with both the Zoning Map and Zoning Ordinances is available for purchase from the Codes Department, or can be accessed online at our website on the Zoning Information page located at https://www.kirksville.gov/p/zoning-information. Any questions can be directed to the City Planner at 660.627.1272.

Building Code – The City currently follows the 2021 International Codes, listed below. Commercial structures include: multi-family dwellings, commercial and industrial buildings, along with accessory structures. Remodeling projects must be designed to meet these codes and all applicable City Ordinances.

- 2021 International Fire Code
- 2021 International Plumbing Code
- 2021 Mechanical Code
- 2021 Fuel Gas Code
- 2015 Energy Conservation Code
- 2020 National Electrical Code

Submission Requirements – Plans submitted as part of a commercial remodel permit application are required to be stamped by a Missouri Registered Architect if there are structural revisions being done in a building larger than 2,000 square feet or is occupied by 9 or more individuals. If the property is under these requirements, simply complete the Commercial Remodel Permit Application. Each page of a plan set is required to be stamped by the appropriate design professional. This also applies to all resubmittals.

- 1. Remodel permit application
- 2. The State of Missouri requires an asbestos inspection to be conducted by a licensed asbestos inspector prior to remodeling of an commercial building.
- 3. 1 electronic, one original set of plans must be prepared by a Missouri registered architect if the floor plan and size of the building exceeds 2,000 square feet or will be occupied by 9 or more individuals.
 - a. Storm water pollution prevention plans (SWPP)
 - b. General specifications
 - c. Fire resistance rating assembly specifications
 - d. Complete Mechanical, Plumbing, and Electrical plans and specifications
 - e. Complete Sprinkler plans and specifications, if applicable
- 4. Site plan drawn to scale and stamped by Missouri registered civil engineer showing:
 - a. Lot dimensions
 - b. Existing and proposed structures
 - c. Driveways, adjacent street(s), sidewalk & utility easements
 - d. Front, rear, and side setbacks
 - e. Address
 - f. North arrow, scale bar and text
 - g. Dumpster enclosure
 - h. Signage, if applicable
 - Site lighting
 - j. Flood Plain regulations met, if required for the property

Fees – Permit fees are due at the time the building permit is issued. Remodeling permit fees for commercial renovation projects are based on the estimated construction cost.

*For current Permit Fees, please refer to our website and the Exhibit A – Fee Schedule. Any questions can be directed to the Administrative Specialist at 660.627.1272.

Review Time – Upon submission of all required documents, the Plan Review Team will begin the review process. This process generally takes approximately two (2) days. Upon completion, you will be contacted regarding the results of the review.

Contractor licensing – All general and sub-contractors are required to have a current Kirksville Business License. To obtain a business license, contact the Business License Clerk in the Finance Department at 660.627.1251. Contractor licenses will be verified by City staff prior to issuing a building permit.

Inspections – Contact the Codes & Planning office at 660.627.1272 to schedule an inspection. Failure to request a required inspection could result in project modifications at the owner's expense. No work should begin or inspection completed until required permits have been obtained.

Fall Protection – Any project site must provide protection to ensure that pedestrians do not unknowingly come onto a project site and be exposed to a fall hazard. Please find additional information regarding fall protection requirements in Chapter 10 of the City of Kirksville Code of Ordinances.

Stormwater Runoff Control – The City of Kirksville is mandated and supports the requirements of its MO-RO40000 Missouri State Operating Permit as required by the Federal Clean Water Act, therefore all sites must manage stormwater runoff. For construction activities that result in a land disturbance of less than one (1) acre, the owner/developer and contractor will be required to follow best management practices (BMP) that are site specific to control runoff; and for construction activities that result in a land disturbance of greater than or equal to one (1) acre, the owner/developer and contractor must obtain a State of Missouri Land Disturbance Permit determined by the Code Enforcement Director.

ASBESTOS

The Missouri Department of Natural Resources regulates the property removal and disposal of asbestos material. Prior to any renovations of a commercial building, an asbestos inspection is required by a Missouri-Certified Inspector. Call 660.385.8000 for paperwork and any information needed. RIGHT OF ENTRY

In the discharge of his/her duties, the Code Official or his/her designated representative shall have the authority to enter at any reasonable hour any building, structure or premise in this jurisdiction to enforce the provisions of the building codes adopted by the city of Kirksville.

PERMIT FEES FOR GOVERNMENTAL & QUASI-GOVERNMENTAL PROJECTS

In December 2003, City Council approved the waiving of building permit fees at the request of governmental and quasi-governmental agencies. City Council Policy #40 outlines the criteria. If you are a tax exempt entity, please provide a copy of your tax exempt letter to see if you qualify to have your permit fees waived.
